The company or organization, if a "for hire" company offering services (such as training) to third parties on a commercial basis, shall offer no other national crane operator certification program, in order to avoid confusion of the CCO acronyms and logo with another program not in compliance with, nor under the control of, the National Commission for the Certification of Crane Operators. This does not preclude a company from issuing a certificate of completion of training, which is preparation for the CCO examination.
2. The company or organization shall submit a written proposal for **each intended use** of the NCCCO logo or acronyms, including a copy of any proposed artwork and related text. The NCCCO logo may not be larger or more prominent than the applying company logo. The company must receive written permission for **each different/updated use** from the National Commission for the Certification of Crane Operators.
3. The company or organization shall place the following wording in a prominent position adjacent to each CCO logo used:

"[Company XYZ] fully endorses the national certification program offered by the National Commission for the Certification of Crane Operators (NCCCO), and will prepare candidates for the CCO tests."

"The company" and "[Company XYZ]" refer to the company applying for use of the logo and/or acronyms.

## NOTES

1. This purpose of this agreement is to facilitate companies using the NCCCO logo and the NCCCO acronyms in approved methods for promoting "preparation courses" for candidates to take the CCO Certification Examination.
2. The NCCCO logo and the NCCCO acronyms are the exclusive property of the National Commission for the Certification of Crane Operators. They may not be used without prior written permission. Any unauthorized use will be grounds for compensatory or other legal action.
3. NCCCO encourages the authorized use of the NCCCO logo and the NCCCO acronyms. NCCCO does not charge for their use in the above manner if approved in writing by the National Commission for the Certification of Crane Operators. Logos are available electronically in various formats, upon email request, free of service charge.
