What's up with OSHA's Crane Personnel Qualifications?

NCCCO's Graham Brent and Joel Oliva were recently invited by the Specialized Carriers & Rigging Association to conduct a webinar to

discuss the legal responsibilities for qualifying employees who work with and around cranes. Among the topics covered were two central issues--certifying by crane capacity and whether certification is equivalent to qualification--that prompted OSHA to announce its intention to reopen the crane rule. CCO Certification Available to Military Personnel

CCO certification examinations will continue to be administered through military bases worldwide following an announcement by DANTES (the Defense Activity for Non-Traditional Education Support) that it has been granted funding for exams in fiscal year 2014. NCCCO is approved by DANTES as a provider of certification programs for serving U.S. military personnel and has provided certification exams for serving military as far afield as Baggram Air Base in Afghanistan. At This Time in...1998

OSHA's Advisory Committee on Construction Safety and Health (ACCSH) met to discuss updating the cranes and derricks standard that had remained largely unchanged since its introduction in 1972. Although unusual for industry to ask government for more regulation, it was a step that many felt necessary to make the standard more relevant and that would, ultimately, make the construction site a safer place. It ultimately led to the formation of the Cranes and Derricks Advisory Committee (C-DAC) and to the publication, almost 12 years later, of the completely revised and expanded crane rule, 1926 CFR Subpart CC.

Also at this time in 1998, NCCCO recorded its 5,000th crane operator candidate tested. To date, more than 150,000 nationally accredited CCO certifications in 20 categories have been issued.
