CCO Certification Featured in The Netherlands

NCCCO Executive Director Graham Brent addressed the nearly 300 delegates attending the two-day World Crane and Transport Summit in Amsterdam, November 10-11.



Taking as his theme, "Certification Comes of Age", Brent outlined how crane-related personnel certification was helping to re-shape U.S. construction. "We've come a remarkably long way in just 15 years," he said, referring to the founding of the National Commission for the Certification of Crane Operators by industry in 1995. "CCO certification was born into an environment where the concept of certification was foreign and where stiff resistance among operators and employers resistant to change was common."

CCO Crane Operators Help with the Capitol Christmas Tree



CCO-certified crane operators played a pivotal role recently in ensuring that the nation's Capitol was appropriately decorated for the season. The towering 65-foot Sierra white fir from the Stanislaus National Forest near Tuolumne, CA, was cut on November 5, requiring two cranes to steady it and then gently place it onto a cradle for its three-week trip across the country. The tree, dubbed "The People's Tree," arrived in Washington, DC, on November 28, when it was carefully erected with another crane on the grounds of the U.S. Capitol building.
